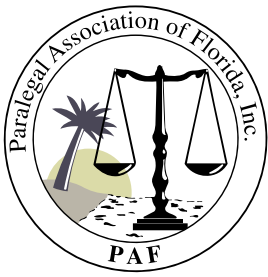

Jupiter Inlet Lighthouse, dating back to 1860, is listed on the National Register of Historic Places. In 2008, it received National Monument status.

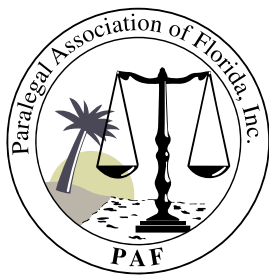

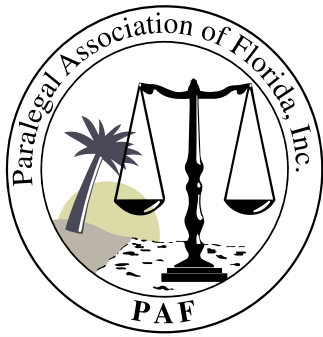
