Providing clean Drinking Water to the Community in Rural Areas is the main concept of the project. Rotary Club of Calcutta has initiated the project PRANADHARA Community Drinking Water through Global Grant with Rotary Foundation with identifying ten locations, water testing and installing of 10 such Water Filtration plants 1000/LPH in the rural villages of West Bengal collaborating with TATA SWATCH JAAL . Ten(10) nos of such big water treatment plants have been installed in different rural areas of West Bengal where nearly 20000 villagers are getting drinking water per day, which has created an impact in community in development of overall health of the common people. Now again the new project Pranadhara II where 20 nos of 500 LPH capacity Water Filtration plant of Tata Tech Jaal will be installed under Global Grant . Through this project the community will have an access to pure clean drinking water in their daily lives which will increase the overall health and hygiene by supply of purified virus and bacteria free drinking water in the rural villages of West Bengal.

#### Project planning

#### Describe the community needs that your project will address.

Clean Drinking Water for Community.. In West Bengal, Arsenic and Fluoride is largely present in ground

water and constantly rising salinity in drinking water sources in coastal areas and adding a problem. Around 84% of the rural population in West Bengal depends on ground water sources. Nearly 83 blocks are affected with Arsenic problems in the state, the other 43 blocks have Fluoride in the drinking water above the permissible limit.

**How did your project team identify these needs?**

Rotary Club of Calcutta has started this project of supplying clean purified drinking water three years back and scaled up the project in the name and style of PRANDHARA through Global Grant with Rotary Foundation. In West Bengal, the team identified the rural water purifications are 1) Boil Water in a Pot 2) Allow to Cool 3) Then use for Drinking. But it was not sufficient to maintain the health and hygiene. Rotary Club of Calcutta through its RCC networks and Rotarians visiting in different villages of West Bengal have found out need of clean purified drinking water. The people are suffering from Water borne diseases which is becoming a big health concern.

**How were members of the benefiting community involved in finding solutions?**

Rotary Club of Calcutta in partnership with TATA Tech Jaal of Tata Chemicals Ltd have earlier identified 4 places three years back , where community needed pure drinking filtered water mostly near the coastal areas of West Bengal in Sundarbans Blocks . RC Calcutta installed TATA Swatch Tech Jaal commercial machines with UHF (Ultra Hollow Filtration ) technology with 1000 ltrs/hour capacity. Recently the club has completed a Global Grant with installing 10 such machines in rural areas of West Bengal supplying more than 50000 ltrs of water per day a ten (10) such locations. giving relief from the water borne diseases to the community

The projects made a positive impact with supply of 99.999% of virus and bacteria free water with eradication of Polio , Hepatitis A & B, E-coli from the water. Now 20 machines 500 ltrs/hr capacity in 20 locations with more beneficiaries.

**How were community members involved in planning the project?**

Now Rotary Club of Calcutta wants to install 20 such Water Treatment Plants with UHF (Ultra Hollow Filtration ) technology with 500 ltrs/hour capacity in 20 rural villages of West Bengal. This machine runs on gravitational pull and no electricity or manpower is needed for running of the machines. The machines will be installed at local RCCs, NGOs and schools where community will get the supply of pure purified virus and bacteria free drinking filtered water on daily basis.

Regular liaison with TATA Chemicals have to be in place for the maintenance of the machines.

For promoting of this project, the club will take the help of the local institutions like announcements in the villages, distribution of leaflets in local languages and through local panchayat offices.

The club have installed such Water Treatment plants in last previous years and has got the experience of promoting these activities and has created an impact in the society with the implementation of earlier Global Grant of Pranadhara - Community Based Drinking Water project with Rotary Foundation.

Tata Chemicals Ltd the manufacturer of the Water Treatment Plants provides an AMC for two years with full maintenance of the machines and changing the filtration parts from time to time. But after two years, what will happen? Rotary Club of Calcutta identified and will install the machines in such institutions in rural areas who have the capacity of maintaining the filtration and the machine with the minimum cost to Tata Chemicals with an AMC. That is why all the machines were being installed earliest at Ramakrishna Mission who is tirelessly working for the upliftment of the rural community.

The machines will have a two year AMC from the TATA Chemicals but after that the machines will be maintained by the Institutions who has the capacity to do an AMC with the parent company for the maintenance of the machines in long term. Tata Swach Tech Jal water purification units are hailed as a sustainable option for water purification, as it works without electricity and water wastage

Tata Swach Tech Jal Community Water Purification units make clean and safe drinking water available for rural communities across 23 Indian states. With this, people from over 300 villages across India now have access to clean drinking water, reiterating Tata Chemicals’ mission of ‘Serving Society through Science’. People residing in rural areas are the major beneficiaries of the Tata Swach Tech Jal water purification units, especially since the lack of water can lead to many waterborne diseases. These units have made filtered water accessible and affordable for them. 116 schools from across the country are also benefitting from this initiative.
